
NOTE:

- 1) It is informed that those who have not completed the course successfully and have arrear are required to collect their hall ticket at the Tapal Section Counter, Ground Floor, U.G. Block.
- 2) It is also informed that students whose names are found in condonation list are required to collect their hall tickets from concerned student section on submission of duly filled in condonation form along with payment for a sum of Rs. 2,000/- (Rupees Two Thousand Only) paid through bank challan towards condonation fee.

It is further informed that the hostel inmates of Boys/Girls hostel are required to collect their hall tickets from the Deputy Warden of the respective hostels on payment of dues, if any need to be paid to the hostel.

NO STUDENT WILL BE PERMITTED TO WRITE THE EXAMINATION WITHOUT HALL TICKET AND NO STUDENT WILL BE PERMITTED TO WRITE THE EXAMINATION AS NOT REGISTERED CANDIDATE.
