### **Hon'ble Mr. Justice Surya Kant, Judge, Supreme Court of India**

Justice Surya Kant started his law practice at the District Court, Hisar in 1984 and soon shifted his practice to the Punjab and Haryana High Court. His Lordship specialized in Constitutional, Service and Civil matters and was appointed the Advocate General of Haryana at a very young age in 2000. His Lordship was designated Senior Advocate in the year 2001 and has appeared in several important matters during his stint. His Lordship was elevated to the Bench in 2004 and assumed charge as the Chief Justice of the High Court of Himachal Pradesh in 2018 before his elevation as a Judge of the Supreme Court of India in May 2019. Justice Surya Kant has delivered several landmark and sensational judgements in his judicial career in all branches of law spanning over a decade and a half.



### **Hon'ble Mr. Justice M.M. Sundresh, Judge, High Court of Madras**

Justice M.M. Sundresh was born in Erode and had his preliminary education in Erode before graduating in Law from the prestigious Madras Law College. Having enrolled as an Advocate, his practice before the High Court of Madras extended from Civil, Writ jurisdiction to even Criminal matters. He was elevated as additional Judge of the Madras High Court in 2009 and made a permanent Judge of the Madras High Court in 2011. Justice M.M. Sundresh has delivered several landmark judgements in the areas of constitutional law, intellectual property laws, arbitration, environmental law, criminal law and civil laws.



### **Prof. T.S.N. Sastry, Vice Chancellor, TNDALU**

Professor Tamma Suryanaryana Sastry started his career as a Teacher of Law in 1987 and has been an academician with over three decades of experience in various administrative and academic roles throughout the country. Prof. TSN. Sastry has authored over 75 research papers throughout his career and has been the guiding light for several students and researchers all over the country. Prof. TSN. Sastry was appointed the Vice-Chancellor of the Tamil Nadu Dr. Ambedkar Law University in the year 2018 and since then, has been leading the University Administration to achieve academic excellence.



### **Shri. V. Giri, Senior Advocate, Supreme Court of India**

Senior Advocate Mr. V. Giri started his practice as a lawyer in Kerala and has appeared in a wide range of matters before the High Court of Kerala. Mr. Giri shifted his practice to the Supreme Court of India in 2009 and soon designated a Senior Advocate by the Supreme Court in the year 2010. Mr. Giri has thereafter, appeared in several sensational matters and represented the Union of India as well, in important cases before the Supreme Court of India. Mr. V. Giri is known for his knowledge of law, pragmatic approach in arguments and deft handling of complicated situations in Court. Mr. Giri has also been appointed an *amicus curiae* by the Supreme Court in many landmark cases.
