It is informed that the “**Instruction Classes**” for the Second Year to Final Year of 5 year (Hons.) Degree Programmes for the Even Semester will be commenced in the month of December 2022 / January 2023.

Therefore, the students who are pursuing second year to final year of the 5 year integrated B.A.LL.B. (Hons.), B.Com.LL.B. (Hons.), B.B.A.LL.B. (Hons.) & B.C.A.LL.B. (Hons.) U.G.
