II. OBJECTS OF THE INDIAN SOCIETY FOR UNIVERSAL DIALOGUE

IV.A EXECUTIVE COMMITTEE

The Executive Committee shall be the governing body with inherent powers of the Society comprising of the following officers:

STAFF ADVISOR shall be appointed by Hon'ble Vice Chancellor.

IV.B GENERAL BODY

The General Body shall consist of member-representatives from each department of each year of study of the 5 year degree courses and 3 year LLB course. The member-representatives shall be appointed by the Executive Committee. The General Body shall be convened as and when required by the Executive Committee. The Executive Committee shall work in tandem with the General Body to formulate the by-laws of the Society.

Selected from each department of each year of study of the 5-year degree courses and 3-year LLB course.

V. CRITERIA FOR SELECTION OF CANDIDATES

The following criteria shall be applied in the selection of candidates for the Executive Committee and the General Body.

VI. APPOINTMENTS

The Executive Committee shall be appointed by the Hon'ble Vice-Chancellor and the Respected Dean of the School of Excellence in Law in consultation with the faculty co-ordinator(s). Such appointments are to be made on the basis of merit as stipulated by the selection criteria.

The Executive Committee shall appoint the members of the General Body in a fair and transparent manner on the basis of merit as stipulated by the selection criteria.

VII. APPLICATIONS

The students willing to apply shall submit the following:

- a) Cover Letter: Indicating the office for which such application is made.
- b) Curriculum Vitae/Résumé: Containing all requisite details (inclusive of certificates) for the selection criteria.
- c) Statement of Purpose: Indicating the student's interest to join the Society, expressing their commitment to the Society.
