

APPENDIX-B

FUNCTIONS OF THE DOCTORAL COMMITTEE

- (i) To discuss, advise and recommend on all matters connected with the candidate's research from provisional registration till the submission of the thesis
- (ii) To monitor the candidate's work once in six months by directing him/her
 - 1. to give periodical seminars on his/her work;
 - to submit reports once in six months positively in the case of full time candidates and once in a year positively in the case of part time candidates to the University on the candidate's progress in research work in the prescribed format (Appendix C);
 - 3. to conduct and supervise a presentation by the candidate of the final draft of his/her proposed thesis for approval before the submission of synopsis of the thesis to the University and to give a certificate to this effect to be submitted along with the synopsis;
- (iii) The supervisor shall suggest a panel of SIX names with the field of specialization in law (three from Northern States and three from Southern States of India) other than the state of Tamil Nadu and not more than one name from each institution to be considered for appointment as examiners by the University, for evaluating the thesis and for the public viva-voce examination, taking special care to see that none of the names so suggested is an immediate relative of the candidate/supervisor.

Provided that persons suggested for appointment as examiners should hold Ph.D Degree who are Professors of Law in a University Department with teaching and or research experience for at least 10 years at the P.G. level along with research publications in law.
