Candidates seeking application by post are requested to send a requisition letter, mentioning the course to which they are willing to apply, along with requisite fee, to the Registrar. Candidates may also obtain application form in person from the Principals of the Affiliated Government Law Colleges by paying prescribed fee.

MODE OF PAYMENT OF APPLICATION FEE: (1) The candidates may obtain the application processing fee in any branch of Indian Bank through remittance challan which may be downloaded from the University website or obtained from any one of the affiliated Government Law Colleges. (2) The candidates may obtain the application form on submission of the remittance challan only. Application processing fee paid through Cash/Demand Draft/Money Order/Cheque/Bank Pay Order etc., will not be accepted. (3) To avail concession on application processing fee, SC(O)/SC(A)/ST candidates belonging to Tamil Nadu shall submit a attested photocopy of the permanent community certificate along with the remittance challan.
