

Main theme of the Seminar

With the adoption of the U.N Universal Declaration of Human rights in 1948, and related covenants in the decades, member states succeeding made a commitment to fundamental human rights for every man, woman and child on the planet. HRE is for training, dissemination and information efforts aimed at the building of a universal culture of human rights through the imparting of knowledge and skills and the moulding of attitudes. It is a lifelong learning process. Human rights advocacy is an integral part of HRE. HR Advocacy is providing a voice to the voiceless. HRE has been promoting about the rights ever since with the Greek and Roman civilization till date through Writers, Jurists, Lawyers, Judges, NGOs and Human Rights Activists etc. This is only a tip of the iceberg. A lot has to be done in this direction.
