It is hereby notified that the Moot Court Association, School of Excellence in Law (hereinafter referred to as the "MCA"), constituted vide Circular of this Office dated 09-07-2026 for the Academic Year 2025–26, is presently inviting applications to fill the existing vacancies in the positions detailed below.
