It is informed that the Law Department of Tamil Nadu is offering Internship opportunity for the young fresh Law Graduates of the State of Tamil Nadu who have completed their Under Graduate degree in Law from School of Excellence in Law of the Tamil Nadu Dr.Ambedkar Law University for the year 2026-2027.

In this regard the department has directed to select top 8 candidates by adhering the prescribed qualifications and method of Selection specified herein.

ELIGIBILITY TO APPLY:-

- (i) Interns shall be citizens of India;
- (ii) Recently passed out Students of 5 Year / 3 Year Law Degree Courses offered in School of Excellence in Law
- (iii) Interns place of birth shall be the State of Tamil Nadu or the interns should have been a resident of the State of Tamil Nadu for a continuous period of 5 years.
- (iv) The intern shall be proficient in Tamil Language (Must have studied Tamil in 12th std.,)
- (v) The candidates who intend to pursue Post Graduate Degree in Law or any other Degree or programme, employment or practice, requiring their compulsory attendance elsewhere are not eligible to be engaged as Interns.
- (vi) The internship shall be for a period of one year.

NATURE OF WORK:-

- (i) Interns may be assigned with work relating to scrutinizing of draft deeds, affidavits and conveyances, observing the court proceedings and for assisting the Law officers in the Department.
- (ii) The interns will be paid a stipend of Rs.25,000/- per month

METHOD OF SELECTION:-

The applications will be scrutinized based upon the following method of selection:-

(i)	Marks for academic performance	5 points
(ii)	Marks for performance in the Moot Court Competition	7 points
(iii)	Marks for Extra – Curricular Activities	6 points
(iv)	Attendance	2 points
Total		20 points

(I) Methods of awarding marks for academic performance:-

1.	If the students has secured more than 80% of marks in his Degree	5 points
2.	If the students has secured less than 81% but more than 70% of marks in his Degree	4 points
3.	If the students has secured less than 71% but more than 60% of marks in his Degree	3 point
4.	If the students has secured less than 61% but more than 50% of marks in his Degree	2 points
5.	If the student has secured less than 51% of marks in his Degree	1 point

(II) Methods of awarding marks for performance in the Moot Court Competition:-

1.	Winner in an International Moot Court Competition	7 points
2.	Participant in an International Moot Court Competition	6 points
3.	Winner in a Reputed National Moot Court Competition	
4.	Runner up in a Reputed National Moot Court Competition	5 points
5.	Participant in a Reputed National Moot Court Competition	4 points
6.	Winner in a State Level Moot Court Competition	3 points
7.	Runner up in a State Level Moot Court Competition	2 points
8.	Participant in a State Level Moot Court Competition	1 point

(III) Methods of awarding marks for Extra – Curricular Activities:-

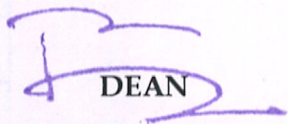
1.	Publication of Law related articles	2 points
2.	Presentation of papers in seminars / workshops	2 points
3.	Winner / Runner up in National / State level elocution competition	2 points

(IV) Attendance:-

1.	Attendance above 85%	2 points
2.	Attendance below 85%	1 point

PROCEDURE FOR APPLICATION:-

1. Interested & Eligible candidates are required to fill the application form annexed herewith.
2. Copy of all the required documents /certificates must be attached along with the application.
3. Points shall be calculated only based upon the proof submitted by the Candidates.

Eligible students are required to submit their duly filled in application along with the required documents (**hard copy only**) by mentioning "Application for Law Internship 2026-2027" to the Dean, School of Excellence in Law, the Tamil Nadu Dr.Ambedkar Law University, Chennai - 600 113, **on or before 29.09.2026 (Tuesday) by 5.00 p.m.**
